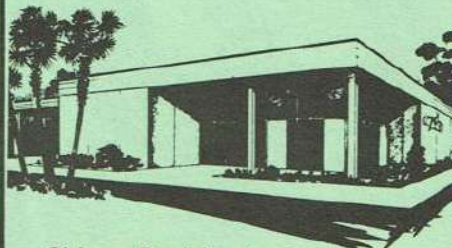

O.B.G.P.O.A CLOSED MEETING

On November 11th, a closed meeting was held at the Clubhouse with President Al Slinkman presiding. The members were cleared at the door by Sergeant-At-Arms, Art Kurt, assisted by Alternate Sergeant-At-Arms, John Auten.

The subject of a change in membership dues came up for discussion and the following was voted on by the membership:
