

But you are in for a rude awakening if you think you can retire from the responsibilities that go with home ownership or from citizenship in your community.

You still must vote to elect officials and on special issues. You still will be affected by how those officials conduct themselves in office as well as by the outcome of the vote on those special issues.

The turn-out of O.B.G. residents on each election day proves you take your voting responsibility seriously.

Voting is truly a privilege by which you are able to participate in the selection of those persons who will represent you in all levels of government.

There is a growing concern, however, over the lack of participation in another process available to you which is equally as important as voting: attendance at meetings of town and county governing bodies.

Your presence at these meetings will send a message to elected officials that you are vitally concerned about issues which affect you, and it will show them you intend to have a voice in matters under their consideration.

There is still another process that can be utilized to express your views. Write to officials and tell them how you feel an issue should be resolved.

PROCEDURES FOR HANDLING COMPLAINTS

1. CORRECTING DEFECTS IN YOUR NEW MOBILE HOME WHILE UNDER WARRANTY.

When your "walk through" was conducted, you were given a form on which you were instructed to list defects to be corrected by the manufacturer - Fleetline. You were requested to allow 15 days to discover defects before turning in your list. *

A suggested procedure for you to follow would be to make a copy of your list before turning it in. Then, when a service representative calls at your home to make repairs or correct defects, be sure all items listed have been taken care of before signing.

If only a portion of the items on your list has been handled, initial only those items on the workman's list which have been completed. Mark your copy as well.

It would then be advisable to submit another list of the uncompleted items - - plus any other problems which have been detected since you turned in your <u>initial list</u>.

An emergency situation will, of course, need to be reported by phone. It is suggested you follow up on the emergency problem by filing a written report - - even after the situation has been remedied. It needs to be a matter of record in the event you have recurring problems.

* (In the year you have in which to report damage, imperfections, shoddy workmanship, etc., you may need to submit several lists. Always make a copy for your files and keep your file in a convenient place for easy referral.)

2. RECOURSE IF THE MANUFACTURER FAILS TO CORRECT PROBLEM.

After a reasonable period of time, if you have tried - - and failed -- to resolve problems with the manufacturer while your home is still under warranty, you can direct a complaint to the Bureau of Motor Vehicles.

The B.M.V. has established bureaus specifically charged with handling consumer complaints concerning mobile homes and recreational vehicles.

Put your complaint in writing and make a copy for your file. The complaint should include the date, your name, address, and phone number.

Direct your complaint to the bureau's district office for Lake County as follows:

The bureau will send an investigator as soon as possible to check your complaint and note the defect and resulting damage.

If your complaint is determined to be legitimate concerning structural or contractual deficiencies, you can expect immediate action.

PROJECTS/PRIORITIES OF TOWN OF LADY LAKE

(As outlined to the May 17th meeting of the Property Owners' Association by Cliff Burgess, Town Manager.)

- 1. There is a need for a SEWER SYSTEM, especially in the 27/441 commercial area. Land, customers and funds are needed.
- 2. The town is continuing to engineer and prepare for bidding to CONSTRUCT/RESURFACE SELECTED STREETS.
- 3. Work continues toward installation of LIGHTING AT THE COMPLETED BALLFIELD; and the Mayor has raised some funds for this purpose.
- 4. In the next budget year, provisions are needed for some ROOF MAINTENANCE.
- 5. ADDITIONAL SPACE will be needed soon for police and administrative offices in the Town Hall.
- 6. The SKYLINE HILLS draining and paving project is about ready for Town Commission action.
- 7. Plans are being made to hire a full-time MAINTENANCE MECHANIC for town vehicles and equipment.
- 8. There is a great deal of interest in exploring the possibility of the town's own FIRE PROTECTION SYSTEM.
- 9. PLANNING and ZONING ORDINANCES need revision and updating.
- 10. The town is currently involved in updating its comprehensive plan to comply with GROWTH MANAGEMENT LAWS.

- 11. Work is being done toward providing a FIVE-YEAR CAPITAL IMPROVEMENT PLAN.
- 12. Land needs to be purchased for use in RECREATION, RAW WATER AND SEWAGE TREAT-MENT.
- 13. Expansion of the town's CENTRAL WATER SYSTEM continues. There are now nearly 800 customers.
- 14. There is a great need for revision of the PERSONNEL POLICIES and the PROCEDURES MANUAL with consolidation into a single book.
- 15. The town is researching the possibility for all types of IMPACT FEES in several areas.
- 16. The possibility of purchasing some of the available railroad property is being explored for the purpose of LIBRARY PARKING and expansion of the City Hall complex.

Mr. Burgess commended the Kiwanis Club for the great job they did in getting the old railroad station and three cars moved for use as a badly needed TOWN LIBRARY.

Is there anyone residing in O.B.G. who does not recall the light-hearted humor and friendly sell of the Burma Shave road signs?

The first dozen or so signs were crudely and hurriedly prepared and placed along High-way 65 in Minnesota late in 1925. Their number rapidly expanded to 7,000 sets.

The spacing of the signs created an enjoyable element of suspense for both driver and passengers as they awaited the pay-off line for the next 38 years.

At 35 m.p.h., it was estimated that the 18 seconds it took to read all six signs was more time and attention than casual viewers gave newspaper or magazine advertisements.

Burma Shave was the first U.S. firm to produce brushless shaving cream, improving vastly on the English version. Not only did they need to woo American men away from the time-honored mug and brush, but they had to do so in the face of growing acceptance of electric shavers.

Realizing the impact of their signs on the motoring public and concerned about the mounting accident rate, Burma Shave began injecting a traffic safety theme into their rhymes in 1935.

"IS HE/LONESOME/OR JUST BLIND/THE GUY WHO DRIVES/SO CLOSE BEHIND?"

"DON'T TAKE/A CURVE/AT 60 PER/ WE HATE TO LOSE/A CUSTOMER." The era's top radio and TV comedians made good use of Burma Shave rhymes in their material. * * The public enthusiastically responded to a contest for new rhymes. * * During Operation Deepfreeze, the U. S. Navy requested (and got) signs to sustain the morale of men stationed in Antarctica.

Many factors contributed to the demise of the little red signs. In any case, when Burma-Vita was sold to Philip Morris, Inc. in 1963, it was decided to replace them with other advertising media.

Having made this decision, equipment and personnel were dispatched across the country to remove some 35,000 individual signs. To the best of the firm's knowledge, the only signs in existence today (outside the factory) are the set requested by the Smithsonian and those donated to other museums. Some may be found along some private driveways and in a few enterprising antique shops. And, of course, in our memories!!
