#### MESSAGE FROM P.O.A. PRESIDENT DOROTHY I. HOKR

Except for annual and special meetings when members are required to show a current membership card for admittance, meetings are open to all members and property owners in the Villages of Orange Blossom Gardens, Silver Lake and County Club Hills who are desirous of becoming members.

We want the P.O.A. to grow and become a special organization of helpful and caring people. The Orange Blossom Gardens Property Owner's Association is first and foremost for the rights of property owners. It will continue in this effort.




