### GOLF CART USE

Several questions have been raised concerning the use of golf carts as the result of the planned cross-over/bridge. The following is meant to provide answers and to include information regarding some old issues.

1) The use of golf carts is governed by Florida statutes. An early statute <a href="limited">limited</a> use to golfers going to and from golf courses. A later statute allows law enforcement agencies to grant other uses on streets within contained retirement communities. Since all but a small fraction of our streets are city streets, the Lady Lake Police Department has jurisdiction over cart use.

There are **requirements** for **safety features**, however, such as reflectors or lights, rear-view mirrors, and use of turn signals. Golf cart drivers are required to stop at stop streets and to use hand signals if their cart is not equipped with turn signals.

Golf carts are **prohibited** from driving on or across Griffin Road and Highway 441/27. They also are prohibited from driving on our streets after dark.

While current statutes do not prohibit **children** from using carts, residents are expected to use discretion in granting permission. An adolescent should be accompanied by the resident or have knowledge of vehicle traffic laws.

2) The capability of a cart to make the trip from the farthest point, cross over on the bridge, play 18 holes of golf and return would be based on a number of factors.

Older carts with two-horse motors might encounter difficulty. The same is true if batteries are three or more years old. Electric carts are good for 36 to 54 holes of golf per full charge and should have no problem. Gas carts have a six-gallon tank and should have no problem, depending on the age and condition of the battery.

- 3) The matter of golf cart insurance is most important. It might be a good idea to check with your agent to determine the extent of your coverage and the need to increase coverage.
- 4) A reminder to all vehicles regarding traffic laws. There are many vehicles parked on our streets for various reasons. When this obstruction of traffic occurs in your lane, you should proceed to pass with caution.

Unless you have sufficient room to pass the parked vehicles without impeding the progress of oncoming vehicles, the law gives the oncoming traffic the right-of-way. You are required to wait until the passing lane is clear of traffic.



### SEPTEMBER MEETING IN REVIEW

At the September 16th meeting, RICK COLPITTS, Lady Lake Police Chief, was our speaker. He spoke about what has happened in the Lady Lake Police Department since he became Chief about one and a half (1½) years ago.

With the cooperation of the Lady Lake Commission, four new police cars have been purchased, winter jackets issued and weapons standardized. Some personnel has changed and new people are being trained to make the department more efficient. Lady Lake has 1.3 police officers per thousand residents. This is less than is needed but with new officers being hired we are making a beginning of catching up to the national average.

Chief Colpitts was in charge of Lady Lake's Hurricane Andrew relief caravan. He was in constant touch with the Homestead police and City Manager. Although he lived in Miami and had been in other hurricanes, the devastation and destruction in the South Florida area is indescribable, he said. There were many problems once the relief supplies arrived in South Florida. Distribution was not coordinated and there was a lack of communication between organizations and various levels of government. Chief Colpitts is very PARTIES CHOICERTO TO DEMOS

proud of how the citizens of Lady Lake responded to the needs of the people who lost so much due to the power of Hurricane Andrew.

The police officers in Homestead lost their homes and yet were on duty as usual. They are trained to help people in these situations even when they have been victims of the storm. It will take years to rebuild this area. He thanked everyone for their help.

Time did not allow him to detail other programs the police department is initiating. There were questions from some people attending. These questions concerned mostly safety and police response. Chief Colpitts is thanked for his interesting and informative presentation.

At the regular business meeting reports from the various committees was given.

The Blood Bank Drive will be Monday, October 12th, at the Recreation Hall. Blood supplies are low and you are urged to be generous and contribute if possible.

The **Home Delivery Mail** petition is still active and we will have a full report at the **October 21st** meeting. The **Nominating Committee**

is still looking for candidates for officers and Board of Directors.

A report on the status of disputed charges for cable TV and garbage pick-up for people who closed on their property before APRIL 9, 1991, stated that the Board of Directors decided to have our Attorney (Harley Herman) file Contempt of Court charges. To date there is no further action. An update will be given at the October 21st meeting.

Many people are receiving an increase in their amenities/maintenance fees. It is difficult to generalize about the increases since each unit has a separate covenant.

At the end of the meeting, Eva Hawkins spoke for Richard Swartz, Commissioner of Lake County and a candidate in the October 1st primary. He was invited to attend our meeting by Eva Hawkins. President Hokr told those attending that the Board of Directors had decided not to invite candidates to our meetings. For that reason, we (the POA) sponsored a candidates meeting

on August 15th for people to hear all the candidates in order to vote intelligently. The POA does not support or endorse any candidates.
