Meeting opened with the Invocation by Glen Swindler - followed by the Pledg of Allegiance to the Flag.

Roll Call of Board of Directors and Liaison Committee Members

Secretary and Treasurer reports were given.

President reported that Legislation Bills were doing well. Senate Bill was scheduled for first reading on the Senate floor. House Bill has to pass Judiciary and Appropriation Committees. Urged membership to write Chairman of those two Committees urging them to support the Bill.

President discussed issue of parking on your lawn - details in Bulletin.

Vice President reported that we were assisting residents on Paradise Drive in their Petition Drive opposing the construction of an access road to the new "LRMC Complex". We do not need another "Panama Place".

Vice-President reported there was a new Bill in the Legislature changing annexation laws. Information was left on table in rear of hall for those interested.

Pat Carter reported on the January 24th Blood Drive. Had 147 donors, of whom 38 were new. The next Drive is April 25th. Pat stressed the need for increased participation – details of this month's Drive is in this Bulletin.

President declared short recess during which the membership enjoyed the "Ice Cream Social".

Meeting was reconvened by the President.

Speaker Bob Ledlie from "Invincible Roofing" gave a presentation covering his company's products. - Mrs. Ruth Pawliczac from S.T.O.P. (Stop Turning Out Prisoners) gave a short talk about her organization and left petitions for the membership to sign.

President asked Leo and Eva Hawkins to stand. Entire membership stood and applauded in recognition of their years of dedicated service. Eva spoke to the membership and bid them farewell.

Bill Gaffney and Betty Bailey conducted the 50/50 drawing.

Benediction was given by Glen Swindler.

President announced coffee would be served after the meeting.

Meeting was adjourned. * * * * *

MESSAGE FROM P.O.A. PRESIDENT BILL RICH

I would like to bring you up to date on the status of our Bills we are trying to get passed by this year's Legislature. The Senate Bill has done exceptionally well. SB-628 passed the "Community Affairs Committee" was amended and passed by the Judiciary Committee and has been through first reading on the Senate floor. Presently it is up for second reading and a vote by the full Senate.

HB 1263, the companion Bill in the House, has not flowed smoothly. It has run into stiff opposition from lobbyists. On March 16th, the twenty-five member Judiciary Committee voted fourteen to eleven against the Bill. However, there was a motion made for reconsideration. On March 23rd, the Committee again rejected the Bill, this time by a vote of thirteen to eleven — one member, left the Chamber before voting. He previously voted in favor of the Bill. His vote would have made it thirteen to twelve — only one vote short of passage. There was no motion for reconsideration.

I have written to the thirteen members who voted against the Bill asking them to resurrect the Bill and requested the Representative who did not vote to please vote for the Bill.

Also, I have written letters to the sponsor and co-sponsors of the Bill asking them to push the Judiciary Committee for reconsideration. This includes Representatives Steven Geller, Debbie Schultz, Ben Graber and Everett Kelly.

I have solicited the support of Mr. Kelly's office to see if the Bill can be added as an amendment to other compatible Legislation. His Legislative Aide is actively working on this possibility.

If any of you know a Representative outside this District, I urge you to call them and ask them to help bring HB 1263 to the floor of the House for a vote.

I will continue to work for the passage of this Legislation. The Legislature stays in session until April 8th.

ALERT! - PLEASE READ - FOR YOUR PROTECTION

Morrison Pest Control is no longer in business. Their accounts have been purchased by Viking Termite Control, Inc., located in Belleview, Florida. Contracts for annual inspections formerly done by Morrison will now be done by Viking. According to the owner of Viking Termite, a young man who worked for Morrison over five years ago is representing himself as an employee of Morrison's. He recently stopped at the home of one of our residents and told them it was time for their termite inspection. The husband was too ill to talk to the man and his wife paid the \$38.00 fee for inspection. He then told the wife they had rats under their house and he would be back in a few minutes. He left and returned with hardware cloth which he attached to the openings under the house. He then told the wife he had poisoned the rats and stopped up all the openings in the house and she owed him \$245.00. She told him she had not authorized the work but he frightened her into paying him. This man has no State license to work in pest control and he is not employed by any licensed exterminator. He drives a gray Dodge pick-up truck which may have a camper cover over the back. It has no name on the side. The County Sheriff and the State authorities are looking for him. If you are approached by anyone meeting this description call the Sheriff's Department.
