President reported that Legislative Study Commission will be taking testimony in Ocala on September 27, 1994 at 9:00 A.M. to 1:00 P.M. in the Central Florida Community College Auditorium. Members urged to attend.

President announced voting on opening our membership to rest of community will be held in November.

President congratulated several members on credible presentations they made at September 19th Commission Meeting regarding location of new Town Hall.

President announced a "Position Paper" on the Town Hall location will be issued by the Board.

Bill Gaffney and Betty Bailey conducted the 50/50 drawing.

Benediction was given by our Chaplain, Pat Sims -- Meeting was adjourned.

MINUTES OF SEPTEMBER 21, 1994 HONTHLY P.C.A. MESTING

I would like to thank Mr. Gary Moyer, District Manager of the Village Center Community Development District for accepting my invitation to speak at our September Membership Meeting. The meeting was well publicized in advance and a large number of residents were in attendance.

Mr. Moyer's explanation of the "CDD's" proposal to purchase the recreational facilities generated a lot of questions from the audience. I think there are a lot of Pro's and Con's to this proposal and should be carefully weighed before I make any comments. We need much more information than has been given so far.

For you residents who live on Tarrson Blvd. in the vicinity of Shay Gate, I am happy to report that you will not have to worry about increased traffic on Griffin Avenue -- The Petition to allow vehicular access from a proposed new bank building has been withdrawn. Old Deed Restrictions on the properties were the problem. This proposal would have increased traffic in an area of our Park that is presently overburdened.

The P.O.A. will be issuing, this month, at the direction of the Board of Directors a Position Letter on the new Town Hall issue. This will be distributed to all residents.

The proposed annexation of Lake Paradise from the County into the Town will be brought before the Planning and Zoning Board on October 10, 1994, at Town Hall. I am making preparations for this meeting and will be representing our members who live around the Lake. Anyone who can possibly attend this meeting should do so!

We will be continuing our discussions on opening our membership to the rest of the community at the October Meeting and will vote in November. The Board thought it advisable not to vote in October because it would mean two closed meetings in a row.

I am continuing to work with the "Blair Group" on our proposal to buy the recreational facilities. I will report to you any new developments as they occur.

Remember, we are electing new Officers and Board Members in November. Please exercise your right as a member to vote!!



ECHOES FROM THE PAST

Material for this article is obtained by researching previously published "Bulletins" going back as far as the first "Bulletin" printed May, 1978.

The following article was published in the July, 1988 "Bulletin".

"Is there anyone residing in OBG who does not recall the light-hearted humor and friendly sell of the Burma Shave road signs. The first dozen or so signs were crudely and hurriedly prepared and placed along Highway 65 in Minnesota late in 1925. Their number rapidly expanded to 7,000 sets. The spacing of the signs created an enjoyable element of suspense for both driver and passengers as they awaited the pay-off line for the next 38 years. At 35 mph, it was estimated that the 18 seconds it took to read all six signs was more time and attention than casual viewers gave newspapers or magazine advertisements. Burma Shave was the first U.S. firm to produce brushless shaving cream, improving vastly on the English version. Not only did they need to woo American men away from the time honored mug and brush, but they had to do so in the face of growing acceptance of electric shavers. Realizing the impact of their signs on the motoring public and concerned about the mounting accident rate, Burma Shave began injecting a traffic safety theme into their rhymes in 1935.

"IS HE/LONESOME/OR JUST BLIND/THE GUY WHO DRIVES/SO CLOSE BEHIND?"
"DON'T TAKE/A CURVE/AT 60 PER/WE HATE TO LOSE/A CUSTOMER".

The era's top radio and TV comedians made good use of Burma Shave rhymes in their material. The public enthusiastically responded to a contest for new rhymes. During operation Deepfreeze, the U.S. Navy requested and got signs to sustain the morale of men stationed in Antarctica. Many factors contributed to the demise of the little red signs. In any case, when Burma-Vita was sold to Philip Morris, Inc. in 1963, it was decided to replace them with other advertising media. Having made this decision, equipment and personnel were dispatched across the country to remove some 35,000 individual signs. To the best of the firm's knowledge, the only signs in existence today (outside the factory) are the set requested by the Smithsonian and those donated to other museums. Some may be found along some private driveways and in a few enterprising antique shops. And, of course, in our memories."


