MINUTES OF AUGUST 16, 1995 MONTHLY P.O.A. MEETING

Meeting opened with the Invocation by Chaplain Pat Sims followed by the Pledge Allegiance To The Flag.

Roll Call of Board of Directors and Liaison Committee Members.

Secretary and Treasurer's Reports were given.

Guest Speaker for the evening was Lady Lake Attorney Mr. Michael Millhorn, who spoke on subjects of Estate Planning, Durable Power of Attorney, Living Wills, Last Will and Testament, Cost of Probating Estates and the advisability of creating a Revocable Trust. Mr. Millhorn has been practicing Law in our community since 1992. His presentation generated many questions from Members.

Vice-President Swindler spoke about the recent proposed changes in the use of the Recreation Halls and other facilities. Management has issued an "Information Booklet" stating that fees will be charged in certain instances. This is something new and the Vice-President explained he has written to the Director of Amenities voicing our concerns.

President Rich remarked about the recently issued "VCDD" proposed budget package for the residential amenities enterprise fiscal year 1995-1996, second draft. A copy was obtained by one of our Members from the District Administrator for the normal copying costs charged by the "VCCDD". The report contains many figures, three of which were of special interest. The figures for Amenity Fees, Debt Service and the cost of operating the Neighborhood Watch Division. Using those figures, it calculates over forty per cent of the amenity fees is being used for those two accounts.

Participation at the new Blood Bank located in LaPlaza Grande has fallen off during the Summer. Please remember to use the OBG/POA Plan Number "961" when you donate. Members are encouraged to renew their efforts to donate!

Legislation Committee Chairman urged members to attend meeting in Tavares on August 29th at 1:00 P.M. State Representative Stan Bainter is conducting a Public Hearing on CDD activities.

Liaison Committee reported that new Committee Members are needed for Units 5, 8, 9 and 12, plus walkers are needed in Units 8, 9, 11, 12 and 13.

VIAL OF LIFE REPORT - DOROTHY HOKR

At the May Meeting of the OBG P.O.A. TAMMY ROGERS of the Lake County Sheriff's Office Community Service Division presented a program on the Vial of Life, 911 Update and Senior Watch.

A supply of the equipment and instructions are available for all residents (Lake and Sumter County) by calling DOT HOKR - 753-5864.

Recently, Dorothy became very aware of the necessity of having your "Living Will" (if you have one) available at home as well as registered with the Doctor and possibly the Hospital. In order for the Emergency Technicians to follow your instructions, the actual "Will" must be available.

If you have a Vial of Life it is suggested that a copy of your "Living Will" be placed in your Vial so it will be immediately available.

THE LAKE COUNTY SHERIFF'S OFFICE

"PROTECT YOURSELF WHEN DRIVING ALONE!"

"There is danger out there for anyone who drives alone. It's unfortunate but women do have to be especially careful, simply because they are perceived to be more vulnerable than men.

"Crimes against women drivers take place everywhere, from parking lots to country roads to highways to city streets. Most are preventable.

"Make sure your car is in top operating condition and keep the following three (3) items in your car at all times:

* Change for phone calls.

* Phone number of 24 hour towing services near your home

* A "HELP CALL POLICE" sign so that you can put it on the highway side window in case of breakdown. Lock all your doors and activate your 4-way flashers.

"Here are some additional helpful hints:

- "1. Always lock your car when you get out and check the backseat before you get in. If your car is a two door, push both seats forward when you get out. Should someone hide in the back seat, you will see them or notice that seats have been pulled back. If this is the case then just walk past your car and go for help.
- "2. Carry a small flashlight in your purse or on your keychain so that you will not fumble trying to fit your key into the lock.
- "3. If you are attacked, noise of any kind may be the best defense. Honk your horn, yell "Fire", or scream. Sooner or later someone will respond.
- "4. Try to get the license plate number as the car drives away.

 Remaining calm that extra minute may mean the difference between
 the driver or attacker being caught by the police or culprit
 doing it again.
- "5. Women need to be aware of what's going on around them. You can't be suspicious of everyone all the time, but careful planning can help you avoid having to make judgments about a stranger. Remember, "You are not alone out there". You are sitting in a 1 1/2 ton package of steel. Use it to protect yourself."
