

NEW TELEPHONE SCAM

There is a new scam going around. You get a call from someone saying they are from the telephone company and checking the line. They ask you to dial 90# and hang up. **DO NOT DO IT - JUST HANG UP.** If you do this, your number will be used for a huge number of long distance calls and your bill will be tremendous.

A couple of good rules to follow to avoid being scammed in any way is:

1) The telephone companies and banks never, never telephone you to verify anything.

 Never give a credit card number to anyone who calls you and asks for it, for any reason.
For soliciting money calls - do not say yes immediately- ask them to send you some literature or say that you do not give to telephone solicitations.

4) Calls soliciting purchases - again ask for literature. Remember, the rest rule of all - IF IT SOUNDS TOO GOOD TO BE TRUE - IT ISN'T.



- * SCANDISK, select C:

- This checks your hard drive for errors.

 - * Right-click START

With the new tax bills coming out, I'm sure you Sumter County residents have noticed that your fire assessment has substantially increased

Several months ago, the Sumter County Commissioners authorized a new fire district to primarily cover the Villages Sumter County residents. This new fire district consists of Villages Sumter County residents and the outside communities of Cherry Lake, Oakland Hills, Glenn Meadow Oaks, Live Oaks, Little Sumter, and Hickery Hammock. The Villages VCCDD was contracted to manage this new fire district.

Villages residents in Sumter County will now pay \$56/vr instead of the old \$30/vr. In addition to our contribution, the VCCDD will add an additional \$41/vr (taken from the amenity/maintenance fund - which they collect and control). This makes a total of \$97/yr per household for Sumter residents in the Villages. The residents of the outside communities will pay an increase of \$10/yr - making their total contribution \$40/yr.

I have the following questions:

With the fee assessment for the Villages being much higher than that of the outside communities, doesn't it appear that the Villages Sumter residents will be subsidizing the entire fire district?

2. With a portion of the Sumter County Villages fee assessment being paid by the VCCDD Amenity/Maintenance Fund, will not the entire Villages population be subsidizing the Sumter County Villages fire department? 3. What extra benefits do the Sumter County Villages residents get for more than a double tax fee? The outside communities get the same fire and rescue service we get. However, they do not have the roving rescue vehicle. Is this worth the maintenance of such a service? The fire station on Rt. 466 appears to be pretty well centered for the entire district

4. Is this new fire district accountable to anyone? Can they increase the fire assessment at their discretion?

I find the above questions rather interesting. What do you readers think? - Carol Kope

WHAT'S UP WITH CDD?

The following is a reprint of an article from the Orlando Sentinel's Homes Section Questions & Answers under "Community Living"

Q: I moved to my new home recently. To my surprise, I was billed for a CDD. I do not remember any mention of a CDD fee, but on reviewing my closing papers, the CDD was mentioned. What is the CDD, and who determines the fees?

A: A community development district is a special form of association. Herbert Fiss, an attorney provided the following description:

It is not a homeowners association as defined under Florida Statute 617. Many times developers market them in error as homeowners associations.

Because it is not defined under FS 617, homeowners do not have the rights and privileges under the HOA laws with reference to the CDD. It is established as a government entity and acts similar to a county or city and even levy fees. But the CDD cannot enforce a community's private a community's private restrictions and therefore must have a separate homeowners association to enforce deed restriction.



HOUSEHOLD TIPS MISCELLANEOUS

- To kill weeds and grass that grows between the cracks on

your cement walk or driveway - don't buy expensive weed killers. Pour cheap, good old household bleach on them. But be careful not to pour the bleach on flowers, etc. - it will kill them also.

- If you want a good inexpensive mouth wash, dilute hydrogen peroxide by adding an equal amount of water. It's a good germ killer and really does not taste too bad.

- When moving pictures around on your walls, remove the possible hole you just made by filling it in with spackling putty (providing your walls are white or off-white). With the rough texture of our walls, the former hole will not show at all.

- If you have a piece of furniture that has a few nicks and scratches, cover the piece (or area) with a matching stain. When the stain is dry, polish the whole thing. Your scratches and nicks will definitely not show as much as before



If you purchased a mobile home or other structure in the United States after August 21, 1995, and if that structure contained plumbing composed of polybutylene pipe with plastic or metal insert fittings (PB plumbing) when you purchased it, this problem can still be fixed. The PB plumbing must have been installed between January 1, 1978 and July 31, 1995.
