Treasurer's report: June receipts were \$7906; expenses \$9866 leaving us with cash flow of negative \$1900. Compared to this time in 2014, revenues were up related to ad revenue while expenses were down related to miscellaneous expenses (supplies and postage) resulting in increased cash over 2014.

The membership report showed that our total membership is down. Traditionally we have grown by roughly 1200 households per year; in 2015 we are up by 100 over 2014. Our plan is to meet and greet Villagers at mailboxes during the annual enrollment period. In the meantime, ask your friends and neighbors if they are members of the POA.
